MInutes

- 1. Call to Order: Dr. Bartosh
 - a. Time: 2:12pm
- 2. Pledge of Allegiance followed by a moment of silence for departed LTEA property owners
- 3. Roll Call: Secretary
 - a. Present: Dr. Bartosh, Pat Bennett, Donnie Davis, George Peterson, Richard Stipp, John Hines (collecting ballots), Sherry Cole, Kerry Butson, Brian McQueen, Bob Neff
- 4. Opening remarks by Dr. Bartosh
 - a. Enough property owners present for a quorum
 - b. Spring is here:
 - i. Boat stickers are needed
 - ii. Golf carts must be operated by licensed individual and obey speed limit
 - c. Dogs must be on a leash when not within fenced-in property
 - d. Future planning
 - i. Make greater use of the website: include helpful videos for new residents (for example, septic, weed control, bylaws and rules)
 - e. Creation of multipurpose building for storage, meetings, family gatherings
 - i. Carle hospital has invested a huge amount of money in community which is bringing in professional individuals that will be residents of Danville, not commuters from Champaign
 - ii. LTEA has a lot of appeal; if residents invest in LTEA with improvements like a community building, it has long term benefits for all of us
 - f. Owners encouraged to come to meetings so that your voice is heard and bring your suggestions to the board
 - g. Comment from Steve Myers: board planning meetings are a good idea and should continue
 - h. Comment from property owner: tired of the roads; get the roads fixed once and for all; side roads never get done; speeding is also an issue
 - i. Comment from Sherry Edwards: thanks to Donnie for the assessment information; questions why the board didn't take action
 - j. Comment from Loren Douglas: in the past LTEA sold lots, now we're buying. Why?
 - i. Clarification from Bartosh

- 1. multipurpose building is not a clubhouse
- There was no vote on buying the lots; Bartosh thought multipurpose building would encourage new buyers; land was an investment
- k. Proposal from property Owner Tammy O'Neil for the three LTEA lots: property owners to take ownership of lots in exchange for road work
 - i. Donnie Davis makes motion, Sherry Cole seconds
 - ii. Stipp states he needs more details to see what this proposal would entail and motion does not pass

- e. Lakes: George Peterson
 - i. Bio chem comes in a sprays for weeds on the lakes; all dependent on the weather; don't drink or irrigate for three days
- f. Roads: Sherry Cole
 - i. Lots of potholes; we all know the money is not there
 - ii. Property owners continue to pitch in and help
 - iii. Comment from property owner: any gravel where folks can get some to fill in potholes
 - 1. there will be some moved in the next week that owners can access
 - iv. Comment from property owner: donated signs that aren't being utilized; speed limit signs are needed
- g. Gates: Rich Stipp

 - 1. Can open the gate from residence
 - 2. can send out invitations to a party; they will get a link and they can get directions
 - 3. gates won't have to be open for everyone for hours now
 - 4. invitation is active for certain length of time
 - ii. For those without smartphones, you can get up to 12 cards
 - iii. \$25 usage fee gets either app and two cards or up to 12 cards without app
 - 1. additional cards are \$5/each
 - 2. These will be brand new cards, should be ready in a month or two
 - iv. Comment from property owner: folks might be using the app too soon and the gate is open before arrival
 - v. Comment from property owner: folks still tailgating
 - vi. Motorcycles don't necessarily close gates
 - vii. Holiday: According to rules, gates have to remain open for these
